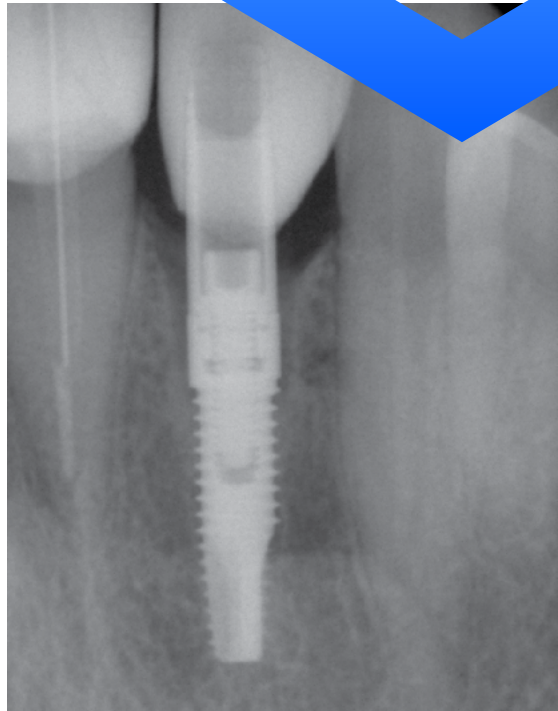

## ABSTRACT

The presentation focuses on the power of Prama implant, how to use it and its relationship with Vertical Freedom Concept (VFC). The session explores and proposes a practical approach to how reducing the unnecessary leads to better clinical outcomes (high quality soft tissues) – all based on the fact that Prama is the one and only intramucosal implant.
